## PROGRAM DESCRIPTION AND RATIONALE

The Bachelor of Health, Physical Education and Sport (Secondary) is a four-year undergraduate initial teacher education degree that prepares teachers for secondary school settings, predominately in Australia. Teacher candidates complete discipline studies in secondary teaching areas as well as discipline specific curriculum and pedagogical studies, general education studies and professional experience

1. If RMIT University intend to make significant changes to the approved program, those changes must first be submitted to VIT for approval.

3. VIT will require information from RMIT University to verify that the program complies with the requirements of a qualification appropriate for entry to teaching, including compliance with the Victorian framework for selection into initial teacher education.
