MINISTERIAL ORDER NO. 1228

Victorian Institute of Teaching Registration Fees

(Version incorporating amendments as at 1 September 2026)

The **Minister for Education** makes the following Order:

1. Purpose

The purpose of the Order is to fix the annual registration fee payable by registered teachers and early childhood teachers, including those having permission to teach, and the fees which must be paid under Part 2.6 of the **Education and Training Reform Act 2006 ("Act")**.

2. Authorising provisions

This Order is made under Section 2.6.77, Section 5.10.4 and Clause 3 of Schedule 6 to the Act.

3. Interpretation

References to sections in Clause 5 of this Order are references to sections in the Act.

4. Period of fee

The fees in clause 5 are for a 12-month period commencing 1 September 2026.

5. Fees

The following fees are fixed pursuant to section 2.6.77 of the Act:

Initial registration (applicants with Victorian qualifications) / permission to teach pursuant to sections 2.6.7(2), 2.6.12A(2)* and 2.6.13(2)	\$175.60
Initial registration (applicants with interstate or overseas qualifications) / permission to teach pursuant to sections 2.6.7(2) and 2.6.13(2)*	\$203.00
Application for second registration pursuant to sections 2.6.7(2), 2.6.12A(2) and 2.6.77A	\$41.80
Annual registration/renewal of registration if paid by 30 September pursuant to sections 2.6.18 and 2.6.21**	\$131.30
Annual registration/renewal of registration if paid from 1 October to 31 December which incorporates the late processing fee/additional fee pursuant to sections 2.6.18 and 2.6.21**	\$173.10
Annual registration /Renewal of registration for second registration pursuant to sections 2.6.18, 2.6.21 and 2.6.77A**	\$29.90
National criminal history check (known as the Nationally Coordinated Criminal History Check) pursuant to section 2.6.22A(3)	\$77.40
Late processing fee/additional fee pursuant to sections 2.6.18 and 2.6.21	\$41.80
Application for approval/renewal of approval of a program or course as an initial teacher education program pursuant to sections 2.6.6D and 2.6.6F	\$3,439.40
Application for approval/renewal of approval of a program or course as a pathway program pursuant to sections 2.6.6N and 2.6.6P	\$3,439.40
Application for endorsement/renewal of endorsement of a continuing education program pursuant to sections 2.6.6X and 2.6.6Z	\$3,439.40
Statement of Current Registration Status pursuant to section 2.6.4(2)(g)	\$59.70

* There may be an additional cost for a Nationally Coordinated Criminal History Check.

** The annual registration fee is payable where registration is not due for renewal.

In all other cases the renewal fee applies.
